Dr. James Otieno Jowi is the Principal Education Officer at the East African Community (EAC) Secretariat (composed of Burundi, Kenya, Uganda, Rwanda, South Sudan and Tanzania) where he coordinates the development and implementation of regional education programs (www.eachq.org). He is the founding Executive Director of the African Network for Internationalization of Education – ANIE- (www.anienetwork.org) a pan-African organization focused on internationalization of higher education in Africa. He is currently a member of the ANIE Board and chairs the research committee. He holds a PhD from the Centre for Higher Education Policy Studies (CHEPS), University of Twente, Netherlands; a Masters in Comparative & International Education, University of Oslo, Norway; a Master of Linguistics & Bachelor of Education from Moi University, Kenya. Before joining the EAC, he was a Senior Lecturer at the School of Education, Moi University, Kenya where he taught Comparative and International Education. His research and publications focus on internationalization, governance and leadership in higher education with a focus on Africa. He sits in several international boards including the African Network for Internationalization of Education (ANIE), the Inter-University Council for East Africa (IUCEA), Austrian Partnership Programme in Higher Education & Research for Development (APPEAR), Norwegian Partnership Programme for Global Academic Cooperation (NORPART), Association of Studies in International Education (ASIE), the technical committee of AUs Committee of Ten Heads of States on Science & Technology and the IAU Expert Committee on Internationalization. He has published extensively on internationalization in Africa and undertaken several studies and consultancies on higher education in Africa.

Prof. Chika Sehoole

Professor Chika Sehoole is a professor of higher education and the Dean of the Faculty of Education at the University of Pretoria. He obtained his PhD at the University of the Witwatersrand, Johannesburg, in December 2002.In 2003/4 he was a visiting Rockefeller post-doctoral fellow at the Centre for African Studies at the University of Illinois in Urbana Champaign. In 2005/06 he was a New Century Fulbright Fellow again, at the same university. He has three- edited scholarly books on higher education, one sole authored book titled "Democratising higher education policy, constraints of policy in post-apartheid South Africa. In 2020-2022 he was appointed a guest editor of the subsection of the Elsevier's Encyclopedia on Education which focused on Higher Education Policy Governance and Practice. As a member of the <u>National Academy for International Education</u> (NAIE), based at the Institute of International Education (IIE), Samia Chasi is an internationally recognized leader in the field of higher education internationalisation. Her career as an international education practitioner, scholar and facilitator spans 25 years.

Samia is currently the Manager: Strategic Initiatives, Partnership Development and Research at the <u>International Education Association of South Africa</u> (IEASA). Before joining IEASA, she worked in international offices of German and South African universities, an agency of the European Commission as well as representations of the German Academic Exchange Service (DAAD), Nuffic and the British Council in South Africa.

Samia is passionate about facilitating deeper understanding and connections between diverse people and institutions by creating spaces for critical engagement and constructive dialogue. Her current research interests lie in Global South perspectives on higher education internationalisation, with a particular focus on critical perspectives and decolonial approaches. Samia holds a Doctor of Philosophy in Education (University of the Witwatersrand, Johannesburg), a Master of Philosophy in Engineering Management (University of Johannesburg) and a Master of Arts in English, Russian and Sociology (University of Rostock).

Prof. Felix Maringe

Felix Maringe is a Professor of Higher Education and the current Deputy Vice Chancellor for Institutional Development, Research and Innovation at the University of Kigali. He is a former Head of the Wits School of Education and Assistant Dean for Internationalisation and Partnerships at the Wits Faculty of Humanities. He researches in areas of international education, leadership in educational environments of multiple deprivation and in decoloniality in higher education.

After completing his doctorate, he was appointed as lecturer at the University of Southampton where he worked between 2004 and 2012, rising to the level of Senior Lecturer. Felix was appointed at Wits as Associate Professor in 2012 and became full Professor in 2015 in the department of Education Leadership and Policy Studies.

Professor Maringe is extensively well published with 122 outputs including 13 edited and jointly authored books. His peer reviewed articles have been cited more than 5800 times and has a Google Scholar H-index of 32 and an i10 index of 55 indicating that 55 of his articles have been cited more than 10 times each. Three of his articles have achieved the status of classics after attaining more than 400 citations each.

He is an NRF rated scholar, an admitted Fellow of the South African Academy of Science and a Fellow of the British Higher Education Academy. He is also the current Editor in Chief of the Journal of Education Studies hosted at the University of Venda.


Zama Sishi
